1.3 Election of Secretary

Commissioner Butler MOVED to elect Commissioner Suggs as the Secretary of the Board of Police Commissioners. SECONDED by Commissioner Wright. Motion carried unanimously.

1.4 Election of Pension Board Chairperson

Commissioner Suggs MOVED to elect Commissioner Wright as the Chairwoman of the Pension Board. SECONDED by Commissioner Collins. Motion carried unanimously.

The Chief reported that the animal control is hosting a fundraiser. More details will be posted on Facebook.

The Deputy Chief reported that 5 new police vehicles will be on the road by the end of the month.

Commissioner Wright inquired as to when the budget process will begin between the City and the Police Department. Chief Perno stated that they are currently undergoing that process with the finance department. The final budget will need approval from the City Council.

8. New Business

8.1 An appeal from DeGennaro's Towing of West Haven

Attorney Thomas Farver, from the Law Firm Farver and Heffernan located at 2858 Old Dixwell Avenue, Hamden CT, spoke on behalf of his client Mr. DeGennaro who was also present. He spoke regarding an incident on the 3rd of February on Locust St. that resulted in the suspension of DeGennaro Towing from the tow list. Attorney Farver claimed that there were no grounds to suspend his client from the tow list maintained by the Police Department. He cited many examples supporting the good character of his client. He asked that the commission repeal his client's suspension.

Officer Buetel gave his account of the incident that occurred on the 3rd of February on Locust St. He stands by his judgement and sides with the complainant against Mr. DeGennaro.

8.1.1 Executive Session regarding the appeal from DeGennaro's Towing

Commissioner Sweeney MOVED to enter Executive Session to discuss item 8.1. SECONDED by Commissioner Suggs. Motion passed unanimously.

At 7:50 p.m. the Commissioners returned to regular session.

Commissioner Suggs MOVED to suspend DeGennaro Auto Truck Repairs towing privileges with an end date of Sunday, February 28, 2021 to resume business on Monday, March 1, 2021 with a 6-month probation period with an end date of September 1, 2021. Any further incidents may lead to a permanent expulsion from the West Haven Police Department tow list. SECONDED by Commissioner Butler. The motion passed with 4 votes in the affirmative and an abstention from Commissioner Wright.

10. Commissioners Report-

Commissioner Butler spoke to City Councilman Mitchell Gallignano of District 4 regarding resident requests to make Clifton Street a one-way street. Sgt. D'Amato gave comments on this

matter and recalled a recent study that showed turning Clifton Street into a one-way street would not improve the traffic flow or speeding situation. He continues to explore options to stop cars from speeding on this street and improve safety when turning onto First Avenue.
