

March 29, 2021

A Special Meeting of the West Haven City Council was held on Monday, March 29, 2021 via remote methods in accordance with City Council rule #30.

Present were Council Members: Quagliani, Conlon, Donovan, Hoskie, Gallignano, O'Connor, Johnston, Hamilton, Massaro, Cohen, McGee, Fanelli and Bruneau. Mayor Nancy R. Rossi was also present.

After the Pledge of Allegiance, the Special Meeting was called to order at 6:01 P.M. by Chairman Quagliani.

The Clerk of the Council read the call of the Special Meeting:
