# 9.1 Promotion - Officer Paul Butler to the Rank of Detective, Effective March 24th, 2025

Vice-Chairman Butler recused himself on Item 9.1. Commissioner Wright MOVED to accept the promotion of Officer Paul Butler to the rank of Detective effective March 24<sup>th</sup>, 2025 pending discussion; SECONDED by Commissioner Suggs.

Deputy Chief Flemmig delivered the following report:

"Officer Paul Butler III has been with the West Haven Police Department for approximately eleven years. He is a hardworking, dedicated officer who takes pride in his job and often goes above and beyond in the performance of his duties. He is currently assigned to the Patrol Division where he serves as an FTO who is always willing to assist the officers he works alongside, offering guidance and advice to help them in the performance of their duties.

Officer Paul Butler has previously served in the Street Crime Unit and as a Task Force Officer assigned to the FBI. He excelled in both of these assignments and was responsible for conducting complex criminal investigations to the fullest extent possible, drafting and serving arrest and search warrants, examining crime scenes and providing testimony as a witness in court. The experience and knowledge obtained in these assignments has developed Officer Butler's investigative skills and prepared him for this next step in his career.

Officer Paul Butler is highly respected by the rank and file, and in his new role as a Detective, he will be entrusted with new responsibilities that will challenge him and help him grow professionally. His enthusiasm and sense of duty paired with his experience and job knowledge will make him an excellent addition to our Detective Bureau.

Paul, I want to extend heartfelt congratulations to you and your family on this well deserved promotion."

## Chief Perno delivered the following:

"Paul, this is a very well-deserved assignment and promotion, something that I know that you will not take lightly. I want everyone in the public to know that this is one of the pieces that we have been putting together with the bureau and hiring; this is the future and I've said this before with some of the other promotions. Officer Butler has only been here a short while, but with every task he's been given, he's taken it to the limit. Officer Butler is one of our best FTO. The only negative aspect of this promotion is the fact that the other Officers won't have your tutelage. I am personally very happy that

you're taking this fork in the road, and I think someday you will transition into a supervisor position. But first, I think you still want to do some investigative chores. There were a lot of people that were looked at for this position; when we identified the names there were approximately 4-5 others that could have fit. That is a testament to everyone in the department involved in training at a level that makes it hard to narrow it down to who stands out. Officer Butler, we appreciate you always stepping up, showing up, coming in, and even doing what you do off duty. Congratulations, God bless, and God speed."
