Councilman Vargo reported that the Fair Rent Commission was finalizing their proposed ordinance. Councilman Donovan reported the Planning & Zoning meeting scheduled for March 25th will have The Kelsey will on the agenda. Councilman Johnstone reported there was a promotion at the Police Department and 119 Police officers are active, with 103 available due to maternity leave or injuries.

VII. NEW BUSINESS

Councilwoman Garthwait reported the huge Sandy Point cleanup in the gardens, thanked the mayor and asked her for an update on The Havens. Mayor Borer stated that she spoke to several developers interested in residential units, and the city is pushing for over 65 units. Councilwoman Callahan and the mayor spoke about the legal battles and roof structure concerning the coffee shop. Councilman Vargo announced the Steeple Rededication at the First Congregational Church on the green is scheduled for April 6th at 10:30 am. Mayor Borer discussed the UNH Partnership which will enable free tuition for first responders and students. She thanked Councilwoman Garthwait and Tommy Green for their work at the Sandy Point cleanup and reiterated that \$500,000.00 for the North End field will come before the City Council. Mayor Borer spoke about the budget and announced that on April 3rd the Budget Hearing at the West Haven High School will take place. The city is having good discussions with Fire Commissioners about their budgets. Home values in the city have increased 56%. She reminded everyone about the tax freeze for senior citizens and tax exemptions for Veterans.
