4. Report of the Chief

Chief Perno reported that R&L Auto Service Inc. and DePalma's Garage and Towing are on a 30-day suspension for excessive no-shows and unavailable.

Chief Perno noted positive participation and conversation at the Community Meeting held on August 4th, 2025 among those in attendance regarding mostly traffic related issues and Al Anon literature distribution.

Deputy Chief Flemmig reported the West Haven Police Department's current staff of 119 Officers with 11 unavailable leaving 108 available Officers.

7. Pension Board

David Moran of Raymond James delivered a report on the fiscal year return of the WHPD Pension stating total portfolio is currently \$142,569,293. Mr. Moran stated that the fund is performing very well in comparison to similar public funds less than \$250M and feels confident that the coming year will result in a similar outcome despite controversy.

Lieutenant D'Amato stated that all Officers who have chosen to opt into the pension payments have been confirmed, numbers have been calculated and are with Raymond James to be finalized.

9.3 Permanent Road Closure of Boylston Street at Abner Street

Commissioner Suggs MOVED to accept the permanent road closure of Boylston Street at Abner Street; SECONDED by Commissioner Carrano. Mayor Borer provided further details stating that the closure had been temporary for a few years. West Haven has received \$1.8M from the state to upgrade the VA neighborhood and will use this closure as an opportunity to pave sidewalks, add fencing, and clean up the unsightly and unsafe New Jersey barriers along this street. Motion carried unanimously.

10. Commissioner's Report

Commissioner Carrano noted the impressive job by the WHPD overseeing major events with minimal issues in recent huge events including the WH Fireworks, Savin Rock Festival, and Community Meeting.

Mayor Borer announced the transfer of some capital funding to support body cameras and oter capital projects for WHPD.
