 - Near the VA Hospital
 - Grant-driven
- Molloy School
 - Conversion to a Community Center underway
 - Senior Center is moving there
 - Remaining Savin Rock Museum collection to be housed there
- Former Masonic Temple 304 Center St.
 - o Getting the "vanilla box" treatment to finish and open
 - No formal input or advisement from the arts community
 - Will continue to be City-owned & operated
 - No managing organization or strategic partners have been announced
 - Path to schedule and access the space is unclear
- Golf Course
 - Most likely site will be near the bocce courts
 - To be discussed at Land Trust Meeting Tues Night Oct 16 alongside a talk on native plantings
- Morse Park improvements
 - The Grind, a baseball coaching company to manage
 - In partnership with the City
- The Kelsey
 - Restaurant at former Conference Center site
 - City will continue to own and lease it out
 - Construction to be completed by May 2026
